Wedding timeline

We know that planning a wedding can be overwhelming, so we try to make the process as easy and stress free as possible. Here's an example of what your journey could look like.



1. Arrange a tour

2. Tentative booking

A tentative booking is held for 7 days, with no obligation. If a signed Registration Form is not received within 7 days, the booking is automatically cancelled.

3. Signed Registration Form and deposit

To confirm a tentative booking, a signed copy of the Wedding Registration Form must be received within 7 days. A **\$1000** deposit is required within 14 days of the Registration Form being received, to confirm and secure the wedding date.

4. Wedding date confirmation

Once the wedding date is confirmed and secured, an email will be sent containing an invoice for the remainder of the venue hire and the Oneday Estate Wedding Toolkit.

5. Venue hire

The venue hire fee is required to be paid, in full, 60 days prior to the wedding date. A reminder invoice will be sent out 30 days prior to the due date.

6. Final wedding meeting

A meeting will be scheduled with the Wedding Coordinator, 21 days prior to the wedding date to discuss and finalise all function details, including guest numbers, beverage options, extra staff and set-up requirements.

7. Beverage, staff and additional fees

Payment for the Beverage Package, extra staff and any additional costs are due 14 days prior to the wedding date. An invoice for this will be sent after the final wedding meeting.

8. Set-up and rehearsal

The venue is available for set-up from 9am on the day of the function, unless previously arranged and approved by Oneday Estate's Wedding Coordinator. Rehearsal times are available in the week leading up to the wedding, by appointment only.

9. Wedding day

It's finally here!

Set-up: 9am-3pm

Ceremony: 3:30pm-5pm

Reception: 5pm-11:30pm

Clean-up & pack-down: 11:30pm-12am

Frequently Asked Questions

When can I drop in to see the venue?

To arrange an appointment please contact our Wedding Coordinator on functions@onedayestate.com.au or **0419 300 281**

Appointments are generally available mid-week or on Sundays. Oneday Estate is also open to the public on Sundays between 12pm and 5pm, when you are more than welcome to have a walk around with a glass of wine.

How do we confirm our booking?

Complete and return our Wedding Registration Form to tentatively book your date, which will be provided by our Wedding Coordinator. A non-refundable deposit of **\$1000** is required within 14 days of us receiving the completed Registration Form to confirm your booking. If the deposit is not received within 14 days your date will be released. Deposit details will be provided upon receipt of your form.

Can we bring in our own alcohol?

No. Due to our liquor licensing regulations, at no time, may any person bring their own alcohol onto the Oneday Estate premises. Any external drinks brought onto the property will be confiscated and the individual(s) will be subject to removal from the function. We are happy to arrange alternative beverages (i.e. spirits, imported beers) on your behalf, so please feel free to discuss this with us.

Does it cost extra to have your ceremony on site?

The ceremony is included in the venue hire fee.

How long do we have access to the property?

Access times are to be confirmed with the Wedding Coordinator prior to your wedding day. However, to make this process as stress-free as possible, we generally provide access to the property the day before (if available) or the morning of the wedding to set up any decorations. Last drinks will be served at 11:30pm and all events must conclude by 12am (midnight) that night.

What is your smoking policy?

Oneday Estate is a non-smoking premises. A smoking area is provided in the driveway in front of the main entrance.

Can we throw confetti?

We do not allow confetti, tinsel, rice or glitter within the grounds of Oneday Estate. Fresh rose petals and bubbles may be used in our dedicated ceremony areas.

My circumstances have changed - can we get a refund?

In the event of a cancellation, deposits are non-refundable. Any subsequent payments will only be refunded if the function date is re-booked by another party and equal to the same value. Cancellations must be made in writing.



Onday Estate Terms and Conditions

GENERAL

You (being each person(s) who signs any agreement with Onday Estate) confirms and warrants to Onday Estate their full capacity and authority to do so. You will be liable in for all costs and charges raised as a result of the agreement. These terms and conditions shall form part of and be incorporated into any agreement between you and Onday Estate and shall prevail over any other document to the extent of any inconsistency

BOOKINGS

Bookings must be made using our Wedding Registration Form. Upon receipt of a Wedding Registration Form, your preferred booking date will be held for a period of 14 days pending payment by you of a non-refundable deposit of \$1,000. The deposit can be paid directly into our Bendigo Bank account (BSB: 633000, Acc No: 157405267) or such other manner as Onday Estate agrees. Upon receiving the deposit your preferred booking will be firm. If a deposit is not received in that time, the booking will be cancelled. All other bookings shall be considered to be tentative for a period of 7 days and shall lapse if a Wedding Registration Form is not received within that time.

PAYMENT

A \$1,000 non-refundable deposit is required at the time of booking to secure your date. The balance of the venue hire fees is required to be paid 60 days prior to the function and all other amounts within the payment timeframe stated in any invoice from Onday Estate. Onday Estate reserves the right to cancel any booking or refuse to provide any goods or services in the event that any payment is not made by its due date. Payment is accepted in cash or by bank transfer. Credit cards payments are also accepted, however, a service fee of 3.5% will be added.

MINIMUM NUMBERS

Function bookings at Onday Estate require a minimum of 50 guests. Variations in time of day and year may provide some flexibility, however once set, this figure will also determine the basis of your account should final numbers fall below the agreed numbers

FINAL NUMBERS AND PAYMENT

21 days prior to the function date, a final meeting will be held, at which time all function details and the final number of guests (including bridal party, children and third-party suppliers) will be confirmed. This will be the final number catered for and charged.

No refunds are available should your numbers reduce after this time nor may any part of the amount charged be credited against other charges associated with the function.

REFUNDS AND CANCELLATIONS

Should unfortunate circumstances require that you cancel your booking, your non-refundable deposit will be forfeited. All cancellations of bookings must be made in writing. Any subsequent payments will be held and will only be refunded if the cancellation is more than 60 days from your booking date, and then in full if the date is re-booked by another party and equal to the same value, and in part of the re-booking is to a lower value. All amounts paid will be forfeited and all amounts invoiced but unpaid will remain payable, in full if your cancellation is within 30 days of your function date and as to 50% of your cancellation is within 60 days of your function date. Changes to the confirmed booking date will be treated as a cancellation. If your booking is required to be cancelled due to an inability of Onday Estate to hold your function, or due to a force majeure event, then all amounts paid by you (other than your non-refundable deposit) will be refunded. A force majeure event means an act of God, war, riot, act of terrorism, fire, explosion, earthquake, flood, natural disaster, declaration of a state emergency or the invocation of martial law. Onday Estate shall have no liability to you under any circumstance beyond the refund of any amounts paid in accordance with this term and shall not be liable for any consequential losses or loss or opportunity or bargain.

PRICES

Prices will be confirmed in writing with every effort made to maintain prices as printed. However, prices may be reviewed at Onday Estate's discretion. All quoted prices are inclusive of GST unless stated otherwise. Prices are current at the time of printing and are subject to change without notice.

BEVERAGES

Your Beverage Package guarantees supply of beverages for four hours and any beverages requested prior to the commencement time or after the finishing time of your function will be charged to individual guests unless otherwise arranged. Due to restrictions on our liquor license, alcoholic beverages cannot be served after 11.30pm. Liquor Licensing dictates that the venue is vacated within 30 minutes of the bar closing. It is your responsibility to ensure the venue is entirely vacated by 12:00am sharp. A fee of \$250 is applicable for every 15 minutes after 12:00am (midnight) where the venue has not been vacated.

ADDITIONAL STAFF

Three bar staff members are included in your venue hire fee. To ensure professional, efficient service and to keep tables and all amenities clean and clear, for guest numbers exceeding 90, we require having more bar staff members (approximately 1 staff: 30 guests). Extra bar staff can be arranged at a cost of \$50 inc GST, per staff member, per hour.

FUNCTION DURATION

Reception venue is available from 4pm-12am. Function hours are as per agreement, with extensions and additional changes subject to prior arrangement and approval. Should you have specific set-up requirements, please arrange this in advance with us. Access to the venue can be arranged for the morning of the event, by appointment only.

CAKES

Due to Victorian Food Safety Laws, Onday Estate has a strict policy on cakes brought into the building. We will only accept cakes that are professionally prepared and delivered by licensed food retailers or registered food businesses. Cakes must be delivered from 12pm and set up at least one hour prior to the beginning of the function.

DECORATORS

Florists or decorators must finish setting up at least 60 minutes prior to the beginning of your function.

DISPLAYS AND SIGNAGE

No items are to be attached, pinned or glued to any wall surface within Onday Estate. All signage must be approved by Onday Estate prior to the function.

ENTERTAINMENT

Should you choose to have entertainment for your function, please have the entertainers contact us one week in advance to arrange for a suitable time to set up on the day. To ensure your day goes smoothly, we recommend entertainers are set up and perform all tests at least 1.5 hours prior to the function kick-off.

FUNCTION EQUIPMENT

We can arrange hire of equipment should you require it. These costs will be quoted to you depending on the equipment required. Details of your equipment needs are required 30 days prior to the function. Equipment will not be hired until such time payment is made in full. Onday Estate shall not be liable or responsible if hired equipment is not made available or provided for any reason.

THIRD-PARTY SUPPLIERS

Supplier access to the venue, for set-up, is from 12pm the day of the function, unless previously arranged and approved by Onday Estate.

All of your contractors' supplies and/or equipment are to be packed up at the conclusion of the function with all belongings being entirely removed from the premises by 10:00am the following morning.

All caterers must remove their equipment and ALL RUBBISH at the conclusion of the function. Reasonable cleaning costs are included in the hire fee, however you may be held responsible for any excess cleaning expenses, such as property damage and third-party's rubbish removal. The customer is required to inform all relevant persons involved in the organising of the function.

PARKING AND TRANSPORT

We have ample parking at Onday Estate in the designated areas. Any cars left on the premises overnight must be picked up by 11:30am the following day.

It is compulsory for pre-arranged buses to be organised to transport guests from the function. Due to liquor licensing regulations, all guests must vacate the property by 12am.

RESPONSIBILITY AND CLEANING

You are required to pack up and remove their gifts and/or wishing well and ALL RUBBISH at the conclusion of the function. Any remaining decorations or belongings need to be entirely removed from the premises by 10:00am the following morning.

Should the premises require any extraordinary cleaning, the costs will be charged to you. Onday Estate will not accept responsibility for the loss or damage to any equipment, merchandise or property left on the premises prior to, during or after the function

ADDITIONAL EXTRAS

Basic furniture in the ceremony and reception spaces are included in the venue hire fee. All other items, such as flowers, candles, centre pieces and so forth are at your expense. Should you require additional changes to the usual layout of our space, such as extra furniture removal or placement, additional charges may apply. Please speak to our Wedding Coordinator about any requests that you may have.

RESPONSIBILITY

Onday Estate will not be responsible for any injury to your guests, invitees or contractors or loss or damage to any their property, prior to, during, or after the function (including delivery). It is your responsibility to take out all necessary insurance including public liability and property damage insurance.

The person(s) signing the agreement will assume responsibility for and shall indemnify and keep indemnified Onday Estate against any and all loss, cost, damages or expense suffered or incurred prior to, during, and after the function in connection with or relating to the function including by way of the actions or inactions of guests, outside contractors or agents and other persons attending the function, whether in the area reserved or in any other part of Onday Estate.

COMPLIANCE

You will be responsible for the orderly behaviour of your guests and Onday Estate reserves the right to intervene where it sees fit. If management has reason to believe that the behaviour of your guest(s) affects the smooth running of Onday Estate's business or reputation, we reserve the right to remove the individual(s) from our premises during the function. All persons attending the function must at all times comply promptly with any direction or instruction given to them by Onday Estate staff.

RESPONSIBLE SERVICE OF ALCOHOL

Onday Estate follows the National Alcohol Beverage Industries Council guidelines regarding the responsible service of alcohol. Onday Estate staff members are instructed not to serve any alcoholic beverages to guests in a state of intoxication. Onday Estate's policy is to serve guests in a responsible, friendly and professional manner. The right to discontinue or refuse liquor service is reserved by Onday Estate.

BYO ALCOHOL

Onday Estate has a Wine and Beer Producer's Licence issued under the Victorian Gambling and Liquor Regulation.

This licence allows Onday Estate to:

Supply their own product for consumption on or off the licensed premises
Supply other liquor for consumption on the licensed premises, and
Carry out wholesale activities and accept telephone and internet orders.

Onday Estate does NOT have a BYO licence. AT NO TIME, MAY ANY PERSON BRING BYO ALCOHOL ONTO THE ONEDAY ESTATE PREMISES.

If any person does bring their own alcohol, in any form, onto the Onday Estate premises, we reserve the right to confiscate the alcohol and remove the individual(s) from our premises during the function and/or terminate the function.
